Workshop Conclusion & Final Discussion

Over the past decade, various natural science studies have demonstrated the numerous negative consequences of environmental degradation caused by human activities. Environmental changes, particularly climate change, affect all aspects of human life and activity. Therefore the protection of the environment is of utmost importance. From a legal point of view, environment might be seen as a special value, an „object of protection“ on the one hand. And on the other hand „a safe, clean, healthy and sustainable environment“ might be grasped as a human right (as it was recognized by the UN Human Right Council in its resolution in 2021). In that sense the role of States and other stakeholders at international and national level is very important.

At the same time, the decisions issued by the European Court of Human Rights (ECHR) on April 9, 2024, and the International Tribunal for the Law of the Sea (ITLOS) on May 21, 2024, pose challenges to the State's ability to safeguard the environment and protect the rights of future generations in the face of competing interests. Several constitutional courts have already anticipated these international rulings by striking down climate-related laws deemed insufficient. Notable examples include the German Constitutional Court in March 2021 and the Korean Constitutional Court in August 2024.

The workshop will focus mainly on this double-side especially from the point of view of international and human rights law.
